THE LEGAL VOTERS OF THE TOWN OF ALBURGH, VERMONT ARE HEREBY NOTIFIED AND WARNED TO MEET AT THE ALBURGH COMMUNITY EDUCATIONAL CENTER IN SAID TOWN OF ALBURGH, ON MONDAY, MARCH 4TH, 2019 AT 7:30 P.M. TO TRANSACT THE FOLLOWING BUSINESS:

NOTE: ALL MONEY ISSUES WILL BE VOTED BY PRINTED BALLOT ON TUESDAY MARCH 5TH, 2019 FROM 7:00 A.M. TO 7:00 P.M. HOWEVER, THESE ITEMS WILL BE OPEN FOR DISCUSSION ON MONDAY EVENING, MARCH 4th, 2019.

POLLING HOURS FOR BALLOT ITEMS WILL BE 7:00 A.M. TO 7:00 P.M. TUESDAY MARCH 5TH. 2019 AT THE ALBURGH MUNICIPAL BUILDING.

ARTICLE #1. TO ELECT BY AUSTRALIAN BALLOT THE FOLLOWING OFFICERS:

ARTICLE #2. TO CONSIDER AND ACT UPON THE REPORTS OF THE TOWN OFFICERS

ARTICLE #3. SHALL THE VOTERS OF THE TOWN VOTE TO APPROVE A BUDGET OF \$673,668.00 WITH THE AMOUNT OF \$520,268.00 TO BE RAISED BY TAXATION, TO BE USED FOR GENERAL TOWN PURPOSES FOR THE FISCAL YEAR 2019 – 2020 (Ballot Item)

ARTICLE #4. SHALL THE VOTERS OF THE TOWN VOTE TO APPROVE A BUDGET OF \$810,350.00 WITH THE AMOUNT OF \$556,850.00 TO BE RAISED BY TAXATION, TO BE USED FOR YEAR-AROUND MAINTENANCE OF TOWN HIGHWAYS FOR THE FISCAL YEAR 2019 - 2020 (Ballot Item)

ARTICLE #5. SHALL THE VOTERS OF THE TOWN VOTE THE SUM OF \$60,000.00 TO BE USED TO BLACKTOP TOWN HIGHWAYS FOR THE FISCAL YEAR 2019- 2020 (Ballot Item)

ARTICLE #6. SHALL THE VOTERS OF THE TOWN VOTE THE SUM OF \$ 55,000.00 TO THE ALBURGH VOLUNTEER FIRE DEPARTMENT INCORPORATED FOR GENERAL PURPOSES FOR THE FISCAL YEAR 2019 - 2020 (Ballot Item)

ARTICLE #7. SHALL THE VOTERS OF THE TOWN VOTE THE SUM OF \$ 15,000.00 TO THE ALBURGH VOLUNTEER FIRE DEPARTMENT INCORPORATED FOR A RESERVE FUND TO BE USED TO PURCHASE EQUIPMENT FOR THE FISCAL YEAR 2019 - 2020 (Ballot Item)

ARTICLE #8. SHALL THE VOTERS OF THE TOWN VOTE TO APPROVE, AN ANNUAL RESERVE FUND, TO THE ALBURGH VOLUNTEER FIRE DEPARTMENT INCORPORATED, IN THE AMOUNT OF \$75,000.00 TO BE USED AS A CAPITAL EQUIPMENT FUND FOR REPLACEMENT OF FIRE VEHICLES AND EQUIPMENT AS NEEDED (Ballot Item)

ARTICLE #9. SHALL THE VOTERS OF THE TOWN VOTE TO PAY THE CURRENT TAXES TO THE TOWN TREASURER IN FOUR INSTALLMENTS WITH DUE DATES AS FOLLOWS: September 10, 2019; November 10, 2019; January 10, 2020 and April 10, 2020

ARTICLE #10. SHALL THE VOTERS AUTHORIZE THE SELECTMEN TO BORROW MONEY IN ANTICIPATION OF TAXES, TO PAY THE CURRENT EXPENSES OF THE TOWN AND TO SIGN NOTES FOR THAT PURPOSE.

ARTICLE #11. SHALL THE VOTERS INSTRUCT THE SELECTBOARD TO ACT NOW TO GENERATE AN ORDINANCE ALLOWING THE USE OF LEGALLY REGISTERED, INSURED AND OPERATED ATV'S ON TOWN ROADS. HELMETS WOULD BE REQUIRED WHERE SEAT BELTS AREN'T AVAILABLE AND A SUGGESTED SPEED LIMIT OF 35 MPH FOR ATV'S (Ballot Item)

ARTICLE #12: SHALL THE VOTERS AUTHORIZE TAX EXEMPT STATUS BE GIVEN TO THE ALBURGH ROD & GUN CLUB. (Ballot Item)

ARTICLE #13. SHALL THE VOTERS OF THE TOWN VOTE TO CHANGE THE TOWN CLERK POSITION FROM A 1(ONE) YEAR TERM TO A 3 (THREE) YEAR TERM BEGINNING WITH THE 2020 ELECTION (Ballot Item)

ARTICLE #14. SHALL THE VOTERS OF THE TOWN VOTE TO CHANGE THE TOWN TREASURER POSITION FROM A 1(ONE) YEAR TERM TO A 3 (THREE) YEAR TERM BEGINNING WITH THE 2020 ELECTION (Ballot Item)

ARTICLE #15. TO TRANSACT ANY OTHER BUSINESS THAT MAY PROPERLY COME BEFORE THIS MEETING.

THE LEGAL VOTERS OF THE TOWN OF ALBURGH ARE FURTHER NOTIFIED THAT VOTER QUALIFICATION, REGISTRATION AND ABSENTEE VOTING SHALL BE AS PROVIDED IN CHAPTERS 43 AND 51 OF TITLE 17, VERMONT STATUTES ANNOTATED.
