ARTICLE #1. WILL THE ALBURGH TOWN SCHOOL DISTRICT AUTHORIZE THE SCHOOL BOARD TO BORROW IN ANTICIPATION OF TAXES?

ARTICLE #2. SHALL THE VOTERS OF THE SCHOOL DISTRICT APPROVE THE SCHOOL BOARD TO EXPEND \$6,982,911 WHICH IS THE AMOUNT THE SCHOOL BOARD HAS DETERMINED TO BE NECESSARY FOR THE ENSUING FISCAL YEAR?
