MINUTES FROM 09/17/2020 MEETING OF THE ALBURGH BOARD OF ABATEMENT

7:00PM – CALL TO ORDER:

- o Meeting called to order at 7pm by Chairman, Armand Premo
- HEAR ABATEMENT OF TAXES FOR GR096, GR098, GR100, RS301 & RS305:
 - Attorney Gawne was not present and did not provide dollar amounts for the abatements being requested.
 - There was some discussion about his request, and it was agreed that his absence and lack of information was sufficient reason to deny his request.
 - Donna L. Bohannon motioned to deny the request to abate taxes for GR096, GR098, GR100, RS301 and RS305, all properties of the Howard Chandler Estate, Attorney Michael Gawne as administrator – seconded by Barbara Baker – all in favor – motion carried – abatement denied.

• HEAR ABATEMENT OF TAXES FOR EA026/28/30:

- O Donna Bohannon in role of Lister, presented information gathered to explain what should and should not be abated.
- o In 2018 the owners of EA026 and EA028, Andy and Josie Henry, grieved to the Listers, the assessed value of the two properties.
- O At that time (2018), the Listers gave the values of \$233,700 to EA026 and \$63,000 to EA028 a combined total of \$296,700.
- O The Henrys then grieved to the Board of Civil Authority and were denied the appeal.
- O They then grieved, in October 2018, to the State appraiser who ruled that the two properties should be combined and that the total assessment of the two should be \$316,000.
- O He ruled that the tax bill for the 2018/2019 tax year and two consecutive years after, this should be the assessed value. (This can change if changes to the property take place.)

- o The ruling from the State appraiser came in July of 2019, by which time the 2018/2019 tax year was closed.
- O The difference between what was billed and what should have been billed for tax year 2018/2019 for EA026 was \$1,541.04. However, they paid \$1,209.03 in 2018/2019 for EA028, leaving a balance owed by them of \$332.01.
- O The amount to be abated for EA026 would appropriately be \$1,209.03, leaving a balance of \$332.01 still owed by the owners.
- o EA028 should not have been billed for the 2019/2020 tax year, as it was combined with EA026.
- o The amount to be abated for EA028 is the full amount of \$3,893.13.
- O Barbara Baker motioned to abate the EA026 amount of \$1,209.03 for the tax year 2019/2020 seconded by Ken Millman all in favor motion carried.
- O Donna L. Bohannon motioned to abate the EA028 amount of \$3,893.13 for tax year 2019/2020 seconded by Cheryl Moomey all in favor motion carried.
- O The amount of \$1,355.03, should not be abated, as there was a bank error. One installment of the taxes was not paid by the property owners mortgage company.
- O The Board agreed that the amount of \$,355.03 for EA030 should not be abated and is still owed to the delinquent tax collector for the 2019/2020 tax year.

OTHER BUSINESS AS PRESENTED:

o No other business was presented.
