## Alburgh Board of School Directors Minutes of October 21, 2013 Alburgh Community Education Center

Present: For Administration: GISU Superintendent Robert Phillips, Principal Janet Cerro; Director of Student Services Beth Hemingway; for the Board, Chairman Mike Savage, Mr. Alton Bruso, Ms. Renee Patterson, Mr. Rene "Skip" Prairie; John Goodrich, recording.

Mr. Savage called the meeting to order at 5 pm and October 7 *Minutes* were approved, as presented, on a motion by Mr. Bruso, seconded by Ms. Patterson.

Superintendent's Report: "Next Generation" Science Standards are being added to the Common Core Transition Plan training, which is scheduled for November 4 and 11. – Mr. Phillips distributed PLANNING SCHEDULE FY 2015 BUDGET PROCESS which includes this month through January, 2014 and concludes at Town Meeting, 2014. – The Superintendent closed with an announcement that a paraprofessional's assignment may be supplanted by a Behavior Interventionist's. (See Board Discussion.)

<u>Principal's Report</u>: Ms. Cerro's report included our school's student census (209) and our continued need for qualified paraprofessionals (2) as well as our need for custodial service (See <u>Board discussion</u>.) – A \$2,000 grant has been awarded to ACEC by the <u>Children's Literacy Foundation</u> and <u>Jolley Associates</u> are presenting a thousand dollar grant to our school's arts programs. – Our School Health Program Coordinator, Dara Kell, is teaching early primary children about personal safety strategies.

Board Discussion: The Board inquired about the distinctions between paraprofessionals and behavior interventionists. Ms. Hemingway explained that the later must be trained and/or experienced in psychology, social work or counselling and must possess a Bachelor's Degree. Paraprofessionals may become "B.I.s" once credentialed. IEP Teams determine if certain students' needs demand the services of Behavior Interventionists if paraprofessional services are determined to be inadequate. — To date, Alburgh has not found a participant in this year's VSBA Conference. — The Board discussed our custodial shifts, needs and personnel and, by consensus, directed Administration to seek a full-time substitute custodian for our school's second shift.

**Board Action**: Mr. Bruso delineated the current accounts payable and Mr. Goodrich moved (Ms. Patterson 2<sup>nd</sup>) "to pay all current ACEC bills as reviewed tonight." (Unan.)

<u>Executive Session</u>: At 5:35 Ms. Patterson moved (Mr. Goodrich 2<sup>nd</sup>) "to enter **Executive Session** to discuss a personnel matter." **Executive Session** ended at 6:04, with no action taken.

Ms. Patterson moved (Mr. Bruso 2<sup>nd</sup>) to adjourn at 6:05. (Unan.)
