NEW BUSINESS:

- Transfer Station per pound rate for non-residents Tabled Topics Transfer Station item will be added here.
 - Several residents have expressed concern to the Clerk and the Selectmen about the per pound rate for out of Town customers.
 - There was some discussion about raising the per pound rate or charging a user fee for out of Town consumers
 - There were some suggestions made about how to establish residents from out of Town patrons.
 - Stickers for Alburgh residents.
 - Verify driver's licenses.
 - These were discussed as options no decisions made at this time.
 - There was discussion about charging a minimum fee for disposal of C&D materials
 - This will be addressed more in the future.

o Tabled Topics:

- Items/ work needed at the Transfer Station
 - There are railings loose near the bailer room
 - o Alton will talk to Bing about doing the work
 - Approval collect household hazardous waste needed
 - o Amy is working on the correct certification that is needed
 - Fork lift needs to be replaced
 - There was discussion about replacing the fork truck with a skid steer or similar machine.
 - Lee will talk to Jason Beaulac about watching the Government Surplus site for a good machine

- The motor for Compactor #3 needs to be lifted and covered
 - o A frame is being built by the Highway Department to lift it off the ground.
 - o Lee will ask that the technician be present when the motor gets moved.
- The cable to the scale needs to be replaced with a longer cable.
 - o The cable is at the Transfer Station Lee will replace it.
- The recycling compactor needs some work done to it. There is rust around the door.
 - Lee or one of the other Selectmen will coordinate someone with a portable welder to do the work.
- Water comes of the baler building roof and pools at the South-East corner of the building. It is icy this time of year.
 - Lee would like to hire someone to install rain gutters and ice spikes on the roof
 - o Quotes will be gathered for this work.
- A tarp is needed for the C&D box before Jim Blair can haul it.
 - o A tarp has been ordered.
 - Until the new tarp arrives, a tarp will be loaned to the Town by the owners of the landfill in Constable.
- Adjustment #3 Jen Hebert update and request
 - Jen informed the Board that she has made several attempts to contact Jackie Rainville and give her the report.
 - o Letter and report will be mailed by certified letter to Jackie.
 - The cat that Jen rescued from a home in Alburgh when the owner moved needs surgery.
 - Tannenberger Veterinary Hospital will take the cat, perform the surgery and rehome him at no cost to the Town.
 - A letter relinquishing "Lovey" to the veterinary hospital is needed.
 - Tyler Gotshall motioned the Clerk write a letter on behalf of the Selectboard authorizing the release of "Lovey Cat" to Tannenberger Veterinary Hospital seconded by Chuck Pease seconded all in favor motion carried

 - The Errors and Omissions Report was presented to the Board for approval
 - There was some discussion about the items on the report
 - Lee Kimball motioned to accept the report as written seconded by Chuck Pease four in favor – one opposed – motion carried

 - ABC would like to build a warming hut next to the skating rink
 - It will measure no larger than 10'X12' and will be built so that it can be moved
 - It will be sided with T-111, have a tin roof, the front will be a window and it will have a flat panel heater.
 - The Board suggested vinyl siding that will match the Senior Center.
 - There was discussion about heating the building.
 - Board would like to be updated on the building and the plan for a power source.
 - Lee Kimball motioned to approve the building of a warming hut without a in favor motion carried.
- o Adjustment #2 Email complaint received asking about "No Parking" signs that were at the beginning of Coon Point Road.
 - Tyler Gotshall motioned that Clerk will reply to the email stating that there is not a parking ordinance in effect at this time—seconded by Lee Kimball—all in favor—motion carried

- Adjustment #4 Tyler Gotshall added a conversation about the Town and Village employees working together on projects.
