ARTICLE #1. WILL THE ALBURGH TOWN SCHOOL DISTRICT AUTHORIZE THE SCHOOL BOARD TO BORROW IN ANTICIPATION OF TAXES? **YES 199 NO 110**

ARTICLE #2. SHALL THE VOTERS OF THE SCHOOL DISTRICT APPROVE THE SCHOOL BOARD TO EXPEND \$6,888,276 WHICH IS THE AMOUNT THE SCHOOL BOARD HAS DETERMINED TO BE NECESSARY FOR THE ENSUING FISCAL YEAR? IT IS ESTIMATED THAT THIS PROPOSED BUDGET, IF APPROVED, WILL RESULT IN EDUCATION SPENDING OF \$18,786 PER EQUALIZED PUPIL. THIS PROJECTED SPENDING PER EQUALIZED PUPIL IS 11.3 % HIGHER THAN SPENDING FOR THE CURRENT YEAR. **YES 152 NO 170**
