Re: Recommendations for the allocation of ARPA funds

Date: September 25, 2023

Introduction

The Town of Alburgh ARPA Advisory Committee (henceforth referred to as the "Committee")" has reviewed and investigated proposals submitted to the Selectboard. In all, the Committee received and reviewed 10 proposals with requests for about \$992,000 in total. There is approximately \$420,000 of remaining ARPA funds to allocate and disburse. The Committee reviewed the Town Plan and considered certain salient points as guideposts in formulating its recommendations. In addition to the proposals, the Committee also received feedback from the public on how best to prioritize these funds. In our discussions, the Committee considered many community needs, including the following: Build upon the Rail Trail and VAST trails; maintain and improve the Town's attractiveness for all residents; support tourism and tourism based economic development; support value-added activities for local farms, including farmers markets; promote activities that facilitate social interaction among residents, invest in disaster preparedness and emergency response measures; fund infrastructure improvements including sidewalk access and cemetery restoration; and promote the general welfare of residents.

Following are summaries of the proposals and the Committee's recommendations shown in tabular and long form.

4. Alburgh Fire Department, Ron Kumetz \$87,700

To upgrade/purchase heating and cooling systems to use the fire hall as an emergency shelter.

5. Rail trail/VAST \$44.400

Signage and trail improvements, structure built over wetlands.

6. American Legion, Phil Pearo, \$50,000

The funds will be earmarked for purchase of an adjacent lot. The new property will be used for additional parking and for farmers markets during the summer season.

7. Alburgh Rescue, Chuck Peas \$50,000

The funds are for startup costs as the Rescue Squad has separated from the fire department.

8. South Alburgh Fire District #2, Alton Bruso, Trustee \$450,000

The funds are for a pump, "inflation" and fifteen hookups for certain residents. The district is in the planning and permitting stages of a new 8 mile extension to Point of Tongue.

9. Alburgh Fire District #1, Ron Haskell, \$74,000 General upgrades and maintenance.

Town Office Land Records, Danielle Choiniere \$90,000
 Digitize land records.

Recommendations

The Committee recommends that the Selectboard approve requested funds for the following:

- 1. Islands in the Sun Senior Center
- 2. Little Peanuts Day Care
- 3. Bicentennial Park revitalization project
- 4. Alburgh Fire Department emergency shelter upgrade
- 5. Alburgh Recreational Trail

Each of these projects is ready to implement, serves valuable community interests and appears to be in the best interests of the Town and its residents. We do wish to note that that additional bids or estimates may be appropriate for the Fire Department emergency shelter. In addition, there are no bids or estimates for the Rail Trail costs, which we anticipate that the Selectboard may wish to review.

Our recommendation for the American Legion is to earmark funds, but to not fund the \$50,000 until a Purchase Agreement is executed and the property is surveyed and ready for sale.

The Committee has agreed that we cannot recommend the following proposals at this time:

- 1. **Alburgh Rescue** startup the Town is already committed to funding \$300,000 to enable its separation from the Fire Department. Additional funding is duplicative.
- 2. Fire District #2 the estimated \$6 million project to extend the system is receiving funds from a combination of state and federal grants. Construction may not begin until 2024 or 2025.
- 3. Fire District #1 there appear to be major issues with the system and equipment that may require a more comprehensive response than that allowed by the finite ARPA funds.
- 4. **Alburgh Land Records** the town clerk indicated that the request for funds should be put on hold. An assistant town clerk has been hired and it is felt that the digitization of land records can be done in house during slow periods at the office.

Funding of \$331,464 for the six projects recommended above would leave approximately \$90,000 to be utilized as the Selectboard sees fit. Some uses that are not covered by proposals include cemetery upgrades, town dump upgrades, additional recreation equipment for the park or school, additional investments in flood preparedness and climate resiliency, or additional grants to the library or the Alburgh Clubhouse.

Thank you to the members of the Selectboard for reviewing these recommendations from your ARPA Advisory Committee, and thank you to all of the organizations and members of the community who submitted proposals and feedback in this process. All recommendations are the result of discussion and unanimous agreement among Committee members.

My name is Megan Ballentine and I am the owner and provider of Little Peanuts Childcare, LLC in the Village of Alburgh. I opened my business on January 3, 2023 and became a Vermont Registered Family Child Care Home Provider on March 12, 2023. One of many purposes for me opening a child care in our town is because there is such a need for the service in our community. I myself was losing daycare within our town because our only other provider will be closing her doors at the end of June of this year. Many families have been impacted with the need for quality child care in our town. I am hoping to be able to help change lives and help families with the service that I am offering.

My purpose of applying for ARPA funds is to be able to expand our outdoor play area with safe and durable playground equipment as well as add safety to our stairs in our home. I currently have 5 children in my care and more children will be attending this summer with very little outdoor equipment and funds to purchase more.

I plan on using the funds to purchase a Lifetime swing set, Teeter totter, Portable Basketball hoop, Soccer Net, Little Tikes Playhouse, Rubber Mulch for the playground, and Railing and gate for the stairs inside the home. I am seeking a grant for \$8,241.56 to cover the cost of these items. As a new business owner I have exhausted my funds to get my inside ready this winter and therefore seeking for extra funds to help get the outside play area ready for summer for the children in the child care.

Playgrounds are essential safe spaces where children can be themselves and express their fun-loving nature while developing crucial cognitive, physical, social and emotional skills. A new play area will allow the children in my care to explore and learn and engage in more free play. Having the different structures and space will give the children the freedom to choose what they would like to play. The CDC recommends that children should have at least 60 minutes of moderate to vigorous physical activity every day and the playground equipment will allow the perfect place to get this done.

Proposal To Alburgh ARPA Committee Revitalization of the Alburgh Town Park

Introduction

The Alburgh Recreation Committee with support from the Islands Pickleball Association submits the following ARPA proposal to revitalize the Alburgh Town Park located behind the Islands in the Sun Senior Center on Main St. Basically, the proposal is to pave the skating rink for winter use and build three pickleball courts within the rink for summer use. Providing year-round use of the skating rink would benefit Alburgh residents of all ages.

Proposed Project

This ARPA proposal has been subdivided into a Base Plan for the skating rink and pickleball courts and Lighting and Playground Options below; the proposed project budget is also included.

Base Plan - Skating Rink/Pickleball Courts

The Base Plan is to pave the skating rink and build three new pickleball courts within the current skating rink space. This newly paved surface within the skating rink would provide multiple uses in addition to pickleball in the summer and skating in the winter.

The skating rink boards would be disassembled and stored on-site. The current gravel rink surface will be graded and compacted in preparation for paving. To fit the three pickleball courts within the skating rink, the rink footprint and corresponding boards would expand from its current size of 60' x 90' to 64' x 104'. Additional rink boards will be added to the existing boards to provide for the expanded size and repairs will be made to restore the existing boards as needed. Once the paving is completed, the skating rink boards would be reinstalled. The attached Base Plan photograph/drawing illustrates the three new paved pickleball courts within the skating rink footprint. Lining of the pickleball courts would be done by the Islands Pickleball Association members.

Lighting and Playground Options

In addition to the Base Plan for the skating rink and pickleball courts, this plan has included options for adding lighting to the rink and another option for replacing the current swing set with expanded jungle gym and/or other playground equipment.

Budget

The following is a summary of the budget totals:

Base Plan - Skating Rink/Pickleball Courts	\$ 75873
Lighting Option (Allowance)	\$ 5250
Playground Option (Allowance)	\$ 35000

A more detailed budget is attached. The following is a list of cost reduction options that would be considered before/during construction:

- Costs could be reduced by utilizing Town road crew(s) for some grading and fill work.
- Paving costs could be reduced by linking court paving with Town paving contract.
- Labor costs could be reduced using volunteer labor to dismantle/reassemble skating rink boards.
- Installation costs of playground equipment could be reduced by using volunteer labor.

Timeline for Execution

After the ARPA funds are awarded, the paving contractor would be secured for the spring/early summer of 2024. This would allow time for the dismantling of the skating rink boards and the grading of the rink surface. The purchase and installation of any playground equipment is not tied to the paving and construction, but would be dependent upon the manufacturer's lead time. Delivery and installation of the playground equipment is also anticipated in the spring/early summer of 2024.

Project Justification

Currently, the skating rink is used only during the winter months as the surface does not lend itself to summer activities. Alburgh residents have hosted Introduction to Pickleball clinics in both 2022 and 2023 in the parking lot of the Islands in the Sun Senior Center that has been lined with 2 pickleball courts. In both years, the number of attendees has exceeded the 2 courts which can handle only 8 players. To date, pickleball play in the Champlain Islands has experienced an 85% growth. These are both indicators of the growth of the sport of pickleball in Alburgh, in the Champlain Islands, and around the world. Use of the Senior Center parking lot places some restrictions on when pickleball can be played as well as safety concerns with no boundaries to stop balls from rolling towards Route 2. Relocating Alburgh's two parking lot pickleball courts, and adding another court, will help address the tremendous growth of pickleball while providing a safer environment for players.

With the 3 new pickleball courts located within the skating rink boards also provides an opportunity for the Alburgh Recreation Committee with support of the Islands Pickleball Association to sponsor summer pickleball camp(s) for children, ages 8-12 and young adults, ages 13-18.

The newly paved surface within the skating rink could provide multiple uses in addition to pickleball play in the summer and skating in the winter. The pickleball nets will be portable so there will be numerous uses for a wide-open 64' x 104' paved surface right off Main St. in Alburgh.

The current playground equipment is limited to a single set of three swings. As part of this park revitalization project, the swing set would be replaced with a commercial playground set including slides, swings and climbing ramps. The new equipment would be targeted at children 5-12 years of age.

Proposal Submission

The Alburgh Recreation Committee with support of the Islands Pickleball Association respectfully submit this ARPA proposal to improve and revitalize the Alburgh Town Park. We believe the combination of a lighted, year-round, multi-purpose paved area within the ice-skating rink plus the addition of new playground equipment would make significant improvements to this Alburgh Town Park for use by Alburgh residents of all ages.



Alburgh is home of the Alburgh Recreational Rail Trail which is approximately 2.9 miles. The Trailhead is located in the center of Alburgh on the Industrial Park Road. This trail is a four season rail-trail that starts in the center of Alburgh and heads east through the Mud Creek Wildlife Management Area ending on Trestle Road in East Alburgh. The terrain is mostly flat and perfect for bicycling and walking. During the winter months this Trail is part of VAST Trails (Vermont Association of Vermont Travelers).

The Alburgh Sno-Springers are an integral part in maintaining the Alburgh Recreational Rail Trail providing trail trimming of brush and grooming during the winter months.

There are 2 "unknown" town-owned beaches/picnic areas that add to the beauty and recreational assets of the Town of Alburgh: Center Bay beach/picnic area and East Alburgh beach/picnic area.

By providing enhancements to these recreational assets of the Town; residents and tourists will be able to enjoy the local beauty that Alburgh has to offer.

Additionally, a grant was received to conduct a wetland delineation on the 60+ acre parcel of land owned by the Alburgh Development Corporation to determine viability of development. During this process it was determined that the acreage is not suitable for development. Therefore, a process began to develop a proposal for recreational hiking trails. The 3 proposed hiking trails are approximately 1.25 miles in length connecting the Alburgh Industrial Park Road to the Alburgh Recreational Trail via a boardwalk. This proposed hiking area would feature bog bridges, a boardwalk, observation areas and benches. Among other things, this proposed hiking area features a vast array of wildlife including deer, turkey, birds and a wide variety of plant life and vernal ponds.

American Legion Post #60 respectfully requests federally allocated ARPA funds to help purchase land adjacent to our existing facility. Post 60 has been interested in expanding our footprint for years as we believe acquiring property to either the north or the south of our building will help us fulfill our service mission which involves support to active duty and reserve military personnel, veterans and their families, and our local community.

An adjacent property acquisition would allow us to expand on the services our Post is already providing to the community that would not be present otherwise. Post 60 is one of only a handful of places that provide food with an attached social component in Alburgh. We rent the building out for many organizations at very reasonable rates, sometimes doing it at no cost. We rent it out for fundraisers, wedding celebrations, funeral gatherings, retirement receptions, and birthday celebrations. We are one of the limited places with the space for the community that has the physical space to hold such events. Additionally, we give back to the community with monies for various benevolent causes in town.

Our vision for expansion includes increased parking space for all events and the ability to use the paved parking lot for events like the farmer's market we just agreed to sponsor as a regular, seasonal event for the community starting this summer. In addition to the Alburgh Farmers Market, this parcel of land has the potential to host other planned events including entertainment events, as well as horseshoe and pickle ball tournaments all located conveniently within central Alburgh.

We are aware of the significant demand for farmers markets in the area, and many of the other activities have either been held at various places in town or on private land that could be centralized at our facility. Additionally, Alburgh is a very Veteran centric town and services for them could be expanded here.

The bottom line is that this purchase would be a win-win for the Town and the Legion. We'd ask for your support in this endeavor and are seeking \$50,000.00 for this purchase.



Dear Selectboard Members:

Last July 2021, we submitted a letter of application for funds under the American Rescue Plan Act. A copy of that letter is attached.

In the interim, we have been able to firm up our funding needs under this program (repair or replacement of aging infrastructure, compliance with State-required improvements to mitigate the effects of climate change, revenue lost during the pandemic).

In 2021, our wastewater backwash system (built in 2001) failed and required major repair (\$15,000). This unexpected expense depleted our reserve fund, leaving us with an operations maintenance shortfall (\$5000 to clean our wet wells due in 2022 — a State-ordered requirement every 5 years).	\$15,000
Our water plant infrastructure is already 16 years old, and our filtration equipment is beginning to fail. This year, we will need to purchase and install two new pressure tanks (\$4,150). Estimate is attached.	\$4,150
